Privacy Statement

We use cookies on this website

A cookie is a small piece of text stored on your computer, phone or whatever you use to surf the Internet. Cookies have many uses, but fundamentally they are used to store information about you on your computer.

We encourage you to accept the cookies our website uses as they help us to improve the user experience for you and many others.

The cookies we use are:

SiteAnalyze web analytics cookie: this cookie is used to help record your use of this website. It is used to collect statistics about site usage such as when you last visited the site. This information is then used to improve the user experience on our website.
